Summary of Transfer Details:

The irrigation well at Veterans Memorial Park has failed and needs to be replaced immediately to avoid the untimely loss of vegetation and/or interim supply of irrigation water through other means at greater cost. Contingent upon approval of the concurrent Type II Transfer 18-03, adequate funds will be available in the Parks Department IST Reserve to pay for the accelerated completion of this project, which is currently slated for \$50,000 of IST funding in FY 2021 as part of the Board approved IST Project Plan.

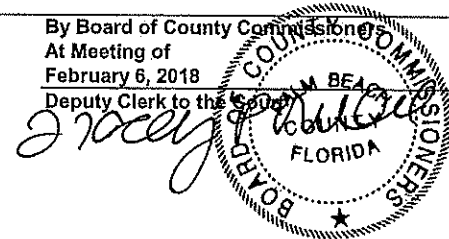

MINUTES & RECORDS SECTION

I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve:

- a) Amendment to the Infrastructure Surtax (IST) Project Plan approved by the Board of County Commissioners on April 4, 2017; and
- b) Budget Transfer of \$2,610,000 within the IST Fund to transfer \$2,500,000 within the IST Fund to partially fund the Ocean Inlet Park & Marina Renovation and Expansion project, \$60,000 within the IST Fund from the Dubois Park Pedestrian Bridge Deck Replacement Project to IST Department Reserves; and \$50,000 within the IST Fund to establish budget for Veterans Memorial Park Irrigation Well Replacement.

Summary: Both the Ocean Inlet Park & Marina Renovation and Expansion and the Veterans Park Irrigation Well Replacement projects were originally scheduled to start in future years as part of the IST Project Plan approved by the Board. Due to public safety concerns given the current state of the seawall at Ocean Inlet Park and failure of the irrigation well at Veterans Memorial Park, both of these projects now need to start this FY rather than awaiting their originally scheduled funding in FY 2021 and FY 2023, respectively. The Veterans Memorial Park irrigation well replacement can be funded using \$50,000 of the \$60,000 of IST proceeds budgeted for FY 2018 that were slated for the Dubois Park Pedestrian Bridge Deck Replacement project in unincorporated Jupiter, which has been completed entirely through grant funding received from the South Florida Water Management District. The Sales Tax Oversight Committee is scheduled to review these requests at their January 18, 2018 meeting. If the requests are not favorably acted upon by the Committee on that date, the requests will be postponed to a future agenda. Countywide (AH)

Background and Justification:

On November 8, 2016, the voters of Palm Beach County approved a one-penny infrastructure surtax for collections beginning January 1, 2017 and continuing for the sooner of 10 years or \$2.7 billion in proceeds before September 1 of any year. Also included was the creation of an oversight committee to audit spending for compliance with approved projects, and the following allocations: 50% to the School District, 30% to the County, and 20% to the Municipalities. Background and Justification Continued.

The proceeds of such tax finance the renewal and replacement of existing capital investments including roadway surfaces, bridges, drainage improvements, canals, park amenities, and government buildings, all of which were deferred during the recent recession and remain outstanding, and projects to maintain levels of service. A detailed project list, Infrastructure Surtax Project Plan, with associated budget was prepared for the projects that are the subject of this item, amongst others, and approved by the Board on April 4, 2017.

Since that time, it has been determined that current conditions demand the replacement of the seawall at Ocean Inlet Park in the Town of Ocean Ridge and irrigation well at Veterans Memorial Park in Boca Raton. Parks and Recreation Staff is recommending that adequate funding for the Ocean Inlet Park seawall replacement be immediately derived by postponing athletic field renovations at West Boynton Community Park in unincorporated Boynton Beach and Buttonwood Park in unincorporated Lake Worth that are scheduled for FY 2018 IST funding until 2023, when the full balance of the IST funding slated for Ocean Inlet Park would become available to undertake the full scope of those projects. The Veterans Memorial Park irrigation well replacement can be funded using \$50,000 of the \$60,000 of IST proceeds budgeted for FY 2018 that were slated for the Dubois Park Pedestrian Bridge Deck Replacement project in unincorporated Jupiter, which has been completed entirely through grant funding received from the South Florida Water Management District.

The proposed changes would have no net effect on the total IST funding allocated to each of the subject projects or overall, but would affect the project schedules. Staff sees those schedule impacts being reasonable and appropriate in light of the prevailing circumstances that have arisen sooner than previously anticipated.
